CERTIFICATION, WAIVER AND RELEASE

I hereby waive, release and discharge any and all claims for damages or death, personal injury or property damage which I may have, or which may subsequently accrue to me, as a result of my participation in this series. This release is intended to discharge the organizing authorities, The Southport Yacht Club, The American Fish Company, The Southport Marina, The United States Sailing Association (US Sailing), promoting club officials, any involved municipalities, other public or private entities, and all employees, volunteers, juries, race committees and sponsors of this series from and against any and all liability that may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

I further understand that serious accidents occasionally occur during boat racing, or boating activities and that participants in such activities occasionally sustain mortal or serious personal injuries, and/or property damages, as a consequence. I knowingly assume the risks of sailboat racing, boating and related activities and release and hold harmless all of the persons or entities mentioned above who might otherwise be liable to me or my heirs or assigns for damages.

I agree to abide by the rules as defined in the Racing Rules of Sailing 2017-2020, the Notice of Race, and the Sailing Instructions.

I acknowledge that equipment regulations and inspection of vessels is for the sole purpose of ensuring fair competition and does not serve as a certification of safety and that it is my sole responsibility to maintain my boat in a properly equipped, seaworthy and safe condition. I represent that my boat is thoroughly seaworthy and safe and all equipment on board, including but not limited to safety and emergency equipment, is properly stowed, in good working condition and is appropriate for this series. I further represent that I and any crew permitted aboard the boat are competent and experience, physically fit, and capable of swimming and treading water in full sailing attire, and have been instructed in the use and location of all safety equipment aboard the boat.

I have read and understood the above waiver and the Notice of Race. I hereby warrant that my boat will be outfitted, equipped and handled in accordance with these conditions; that she will have all the required equipment aboard; that she is seaworthy in hull, rig and gear; and that she will be completely and competently manned. Weather and sea conditions must be evaluated by each skipper and his/her crew and I acknowledge that I am responsible for determining whether it is safe for my boat to participate or continue to participate in any race, event or related activity of this series.

I give permission for the free use of my name, picture and voice in any broadcast, telecast or print media account of this series in any medium.
